



AUTHORIZED DEALER AGREEMENT

Terms and Conditions

This agreement, between Snappin Turtle Tie Down Products and the undersigned is made for the expressed purpose of authorizing retail sales of Snappin Turtle Tie Down Products through the undersigned's business entity. These sales are to be conducted in a localized manner and should conform to generally accepted good and principled business practices. **Your business will receive "Level D" Pricing.** By accepting the status of Authorized Dealer of Snappin Turtle Tie Down Products, the undersigned states and verifies that their business entity conforms to the following requirements and agrees with the following terms and conditions. :

- 1 The undersigned operates a legitimate retail business and sells or provides automotive products or services.
- 2 The undersigned operates a business that has: an actual physical location and address; an actual telephone listing; appropriate business licenses; and a respectable credit history.
- 3 The undersigned's business entity is situated in a geographic area that will support competitive selling of Snappin Turtle Tie Down Products or is in a location not currently supported by a Snappin Turtle Tie Down Products dealer.
- 4 A \$10.00 drop ship fee will be applied to each drop shipped order for all non-stocking dealers.
- 5 A \$5.00 drop ship fee will be applied to each drop shipped order for all stocking dealers.
- 6 The undersigned will not pursue advertising or promotional activities that portray Snappin Turtle Tie Down Products in a way that is inconsistent with or contrary to the advertising and promotional standards of Snappin Turtle Tie Down Products. A reseller may not use, at any time, for any purpose, advertising tactics or methods, which are detrimental to the image or perceived value of Snappin Turtle Tie Down Products.
- 7 The undersigned will not sell or advertise Snappin Turtle Tie Down Products on any Internet address other than their primary business address unless given prior approval from Snappin Turtle Tie Down Products. Authorized Dealers who do not maintain the aforementioned standards and practices will have the delivery of Snappin Turtle Tie Down Products discontinued and terminated.
- 8 All Authorized Dealer shipments will be Credit Card for the first 90 days of our business relationship. Dealers may request a credit application for account terms after this initial period (90 days).
- 9 Upon providing a 30 day written notice, Snappin Turtle Tie Down Products reserves the right (for any implied or explicit reason) to render this agreement null and void. Snappin Turtle Tie Down Products retains the option of repurchasing all or any portion of the Authorized Dealer's remaining inventory (at the original cost at time of shipment) upon the termination of the relationship between parties.
